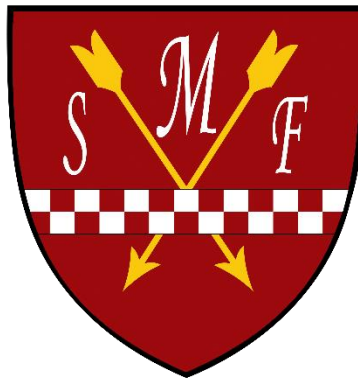

## **Accepted Payment Options**

It is the policy of Scott McAulay Family New Options Funeral Service that a uniform payment process applies to all arrangements. Financial obligations related to our firm are to be completed at the time of the arrangements or forty-eight (48) hours prior to the first viewing, scheduled funeral service, cremation or use of merchandise.

### PROFESSIONAL SERVICES

**Basic services of funeral director and overhead:** \$ 1,130.00

This fee for our basic services will be added to the total cost of the funeral arrangements you select. This basic fee includes readiness to serve, making arrangements for the final disposition, and a prorating share of taxes, licenses, business expenses required to serve the public and death certificate administration. A prorating of the fee is already included in our charges for direct cremation, immediate burial, forwarding of remains, or receiving remains.

**Removal:** \$ 595.00

Vehicle to transport remains to the funeral establishment includes staff, 24 hr. service, for traditional services and graveside.  
Does not cover direct cremation packages.

**Additional staff needed for removal for in home or over 250 lbs.:** \$ 50.00

**Refrigeration minimum for 3 days:** \$ 150.00

Daily rate \$50 or portion of a day.

**Professional Embalming:** \$ 350.00

"Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial."

**Autopsy repair or other radical procedure repair:** \$ 150.00

**Tissue and bone donation repair or other radical procedure repair:** \$ 250.00

**Other preparation of remains:** \$ 200.00

Dressing of remains, cosmetic preparation, basic hair styling and placement in selected container/casket

**Janitorial Service:** \$ 75.00

Cleaning and reorganization of facility/church after funeral/viewing services.

**Staff for evening service and/or viewing, at a church of your choice, or your home. (after 4pm):** \$ 400.00

Sat add \$400, Holiday add \$500 Plus \$ 150 for each additional hour after 3 hours

**Staff for funeral ceremony and committal service :** \$ 370.00

Sat add \$400 Holiday add \$500 Plus \$ 150 for each additional hour after 3 hours

**DIRECT CREMATION PACKAGE:**

**Price range, \$1095**

*If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard, or composition materials (with or without an outside covering. The containers we provide are cardboard. Does not include embalming, dressing, viewing or ceremony.*

**Direct Cremation Package:** \$ 1095.00

Includes: discounted basic services of funeral director, removal vehicle to transfer remains, refrigeration, filing certificate of death, crematory fee, alternative container, Taxes. **Does not include dressing of deceased, viewing, or any ceremony.**

With in Home arrangement \$ 1,195.00

**Direct Cremation using container provided by the purchaser:** \$ 1095.00

Includes: discounted basic services of funeral director, removal vehicle to transfer remains, refrigeration, obtaining certificate of death, crematory fee. Does not include dressing of deceased.

**CREMATION FEES FOR PERSONS WEIGHING MORE THAN 300 LBS ARE NOT PART OF THE ABOVE PACKAGES**

**Price range, \$ 1,540 to \$ 1,065**

A decedent with a weight exceeding 300 Lbs. will incur additional fees and restrictions as set forth by the crematory. The limitations and restrictions on the cremation chamber, facility and alternative container are at the sole discretion of the crematory operatory and crematory manager. The alternative cremation container of decedent weighing from 300 lbs. to 550 lbs. is \$ 425.00.

**300 - 350 Lbs.:** additional \$ 400.00

**351 - 400 Lbs.:** additional \$ 600.00

**401 Lbs.:** \$ various by weight

**Memorial Cremation Package:** \$ 1795.00

Package includes: Basic services of funeral director, transfer of remains, refrigeration, obtaining certificate of death, memorial ceremony, crematory fee, alternative container, and Sales Tax.

**Witness insertion into crematory:** \$ 200.00

**Identification of decedent:** \$ 250.00

5 Immediate family members only, 30 minutes at East Fullerton Care Center, M – F 10am to 4pm, no cosmetic improvements. Does not include dressing of deceased. Additional fees will apply after 4pm (fee is \$ 75.00 per 30 minutes, no later than 8pm)

**Identification of decedent and witness of insertion into crematory chamber:** \$ 350.00

5 Immediate family members only, 30 minutes at East Fullerton Care Center, M – F 9am to 3pm, no cosmetic improvements. Does not include dressing of deceased. Travel to crematory for insertion process, witness insertion (latest available witness cremation 3:30pm).

**Witness Complete Cremation Process:** \$ 575.00  
 5 Immediate family members only, 30 minutes at East Fullerton Care Center, M – F 9am (only time available 9:30am), no cosmetic improvements. Travel to crematory for insertion process, witness insertion into cremation chamber and receiving at finalization of process.

**Special Handling:** \$ 100.00  
 Mailing of cremated remains. Domestic shipping and handling with USPS Priority Mail Express.

**Scattering cremated remains at sea:** \$ 100.00  
 Off the coast of Orange County not witnessed by family (Witness scattering price quotes by request)

**Ariel scattering over land or sea:** \$ 850.00  
 Ariel scattering of ashes over Southern California areas of sea or land

**Scattering over land by foot travel:** \$ 350.00  
 Travel by foot into Sierra Nevada Range within 350 miles, not witnessed by family.

Package includes: discounted basic services of funeral director, transfer of remains, refrigeration, EDRS filing the death certificate, transport to the place of interment. Does not include embalming, viewing, or ceremony, or cemetery charges.

**RECEIVING REMAINS**  
 Price \$ 1,195.00

Package includes: discounted basic services of funeral director, transfer of remains to facility and holding remains in refrigeration or casket arriving with remains.

**FORWARDING OF REMAINS**
