**PROFESSIONAL SERVICES.**

Basic services of funeral director and overhead: \$ 1,595.00

This basic fee includes readiness to serve 24 hours a day, arrangement conference for the final disposition, and a proportional share of taxes, licenses, insurance expenses, business expenses required to serve the public and death certificate administration. A proration of the fee is already included in our charges for direct cremation, immediate burial, forwarding of remains, or receiving remains.

Removal: \$ 595.00

A vehicle and staff to transport remains to the funeral establishment includes staff, 24 hr. availability. *Within 25 miles of the office.*

Additional staff needed for removal for in home or over 250 lbs.: \$ 50.00

Refrigeration: \$ 150.00

Daily rate \$50 or portion of a day.

Professional Embalming: \$ 400.00

"Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial."
